The following students have been selected for admission to the Master of Business Administration (Two-Year Full-time) Course of IISWBM. The session will commence on Wednesday 2nd July 2018 at 11:30 hours.

1. The fees for the course are as follows :

Fee for the 1st year: Rs. 2,99,000/- (including admission, tuition and development fees)
: Rs. 5,000/- (refundable Library Caution deposit)
: Rs. 5,000/- (refundable Security deposit)

Fee for the 2nd year: Rs. 2,91,000/- (including tuition and development fees)

The sum of Rs. 3,09,000/-, payable fee for 1st year, may be paid by any of the following options:

A/c payee bank draft / pay order / banker's cheque, etc. in favour of "IISWBM"
RTGS / NEFT transfer to IISWBM, State Bank of India, Surya Sen Street Branch, Kolkata; A/c No. 10252384198; IFSC : SBIN0003496

A copy of the receipt should reach MBA office of the Institute either by hand or by courier on or before 20th April 2018.

2. In addition to the above fees, you will be required to deposit an additional amount of Rs. 10,000/- by 31st July 2018, to meet the expenses relating to various management events, student activities.

3. The admission of candidates whose results of final examination are yet to be published, will be provisional subject to passing the eligible degree with minimum 50% marks in aggregate. The relevant documents will have to be submitted by 28th September 2018.

4. Candidates who have passed their degree examination from a university other than Calcutta University must get a Migration Certificate and submit the same to Calcutta University within one month from the date of commencement of the course.

5. Final admission will be based on your qualification being approved by the University of Calcutta for this course.

6. Students are required to furnish details of their local guardian including address, contact telephone number and email ID.
